## TERMS & CONDITIONS

### SECURING A BOOKING

To secure your wedding party dates, a 50% deposit is required. A written confirmation and receipt (tax invoice) will be provided. The remaining 50% of your account is due 2 months prior to your function along with the bond.

### ACCOUNT PAYMENT

Accounts can be paid via Direct Deposit. Credit card facility is also available with a 1.75% surcharge – please contact us at [info@stonebarn.com.au](mailto:info@stonebarn.com.au) or call 0424 835 166.

### BOND

A bond payment of \$1,000 is required two months before the booking date, and, if necessary, utilised as a cleaning/breaking bond to cover any cleaning of the premises over and above what is normally required, or other damage to the property or any breach of the Stonebarn Terms and Conditions. Bond is returned immediately upon post-stay inspection, but within a maximum of 14 days.

### CANCELLATIONS

With regard to cancellations *up to* four months prior to your booking date, we will provide a 50% refund of your deposit amount. Cancellations *within* four months of your booking date will result in us keeping your 50% deposit amount with no refund. No refund will be issued for cancellations within two months of your booking date. Cancellations must be made in writing to [info@stonebarn.com.au](mailto:info@stonebarn.com.au)

### MAXIMUM NUMBERS

The maximum number of guests allowed is 100. Larger weddings may possibly be arranged, please contact us to request.

### MAXIMUM ACCOMMODATION NUMBERS

The maximum number of guests permitted to stay overnight on the Stonebarn property is 16. No variations are allowed without prior arrangement.

### CAMPING & CARAVANS

Absolutely no camping or caravans are allowed anytime.

### RESPONSIBILITY FOR GUESTS & CONDUCT

Stonebarn does not accept responsibility for damage to or loss of any client and guest property, including gifts left on the premises prior to, during or following a wedding or stay.

Any damage caused by guests will be the financial responsibility of the organiser/booker and the costs associated with repairs or cleaning will be charged accordingly.

The duty of care to all clients and guests regarding the responsible service of alcohol is the responsibility of the wedding organiser/booker. You must abide by the responsible service of alcohol laws, as displayed on the kitchen wall.

At no time will the organiser/booker commit any act or permit its employees, agents or invitees to commit any act that is illegal or offensive or is in breach of any statutes, by laws, regulations, or any other provisions having the force of law, included but not limited to the Liquor Licence and Fire Regulations.

## TERMS & CONDITIONS, CONTINUED

### SMOKING

No smoking is allowed inside the lodge. Please contain smoking to the designated smoking area outside the kitchen near the citrus orchard, and outside the gazebo (cigarettes are to be extinguished in the sand buckets provided). Smoking is a fire risk. You will be charged for the extra cleaning service for any cigarette butts found outside the designated smoking area.

### FURNITURE

Please don't move the furniture in the lodge – if you are using any pieces of furniture for photos etc, please put everything back in its place on departure. The 12 seater table in the dining room cannot be moved and please do not move the pots on the verandah as they are very fragile.

### CELEBRATORY DECORATIONS

Organisers are financially responsible for any damage sustained to fittings, property or equipment by the client, guests or outside contractors prior to, during or after the event. Please do not nail, screw or staple any items to walls, doors or other surfaces without approval from Stonebarn. Please remove and/or clean any items used prior to departure (eg, rose petals etc).

### CLEANING

Standard cleaning, including linen and towels, is included in the venue hire price. Excessive or additional cleaning of linen, towels & bathrobes will incur additional charges.

### RUBBISH

Please place all rubbish, including recyclables, in the large commercial bin behind the gazebo.

### FIRES

When there is a total fire ban absolutely no open pit or other fires are allowed anytime.

### FISHING & SWIMMING

Swimming in the dam is not permitted during weddings and events due to insurance reasons. There is no fishing allowed – please note that the council require public fishing licenses for fishing in public waters (eg, Warren River).

### TRUFFIERE RESTRICTIONS

Please stick to the paths. No guests are permitted to enter the truffière due to farming operation bio-security reasons. You may take photos with the truffière trees as a background and there is one demarcated area that makes a natural aisle that may be utilised. Absolutely no cars are allowed in the truffière, all traffic must stick to the designated tracks.

### UPDATES, PRICING & CANCELLATIONS

Stonebarn reserves the right to update these Terms and Conditions at any time. Prices are current at time of quotation but are subject to change without notice. Should management have cause to believe that a function will adversely affect the running of our business, its security or reputation, we reserve the right to cancel the function booking.

### ACCEPTANCE OF TERMS

By paying the 50% deposit, you agree that you are personally liable for the payment of the balance of the total invoice and bond, and accept the above Stonebarn Wedding Terms & Conditions.
